Tuition

- Tuition will be payable in 10 equal monthly amounts.
- Tuition is due on the 1st of every month August-May.
- A late fee of \$50 will be assessed after the 10th of the month.
- A \$30 fee is assessed for any check not honored by the bank.
- Paid tuition is non-refundable.

Instructional Fee

- Student Fees are charged per student, per academic year. This fee includes a technology fee, workbooks, some field trips, and student planner.
- This annual student fee is due June 1st upon acceptance of the student, whichever is first.

Registration Fees

- New Student Application/Waitlist Fee - \$25.
- Annual Re-enrollment Fee (Preschool - 8th Grade) - \$175 per year for existing students.
- New Student Registration Fee (Preschool - 8th Grade) - \$250 per year.

Tardy & Late Drop Off Fees

- The West parking lot gate closes at 8:10am. Students arriving after the gates close must enter through the school lobby.
- \$10 per tardy, per student, in excess of three(3) tardies, per trimester.

Payment Information

Payments: Monthly tuition payments must be set up with FACTS Tuition Management, an outside billing service allowing parents flexibility in making payments.

There are three payment options available:

- **Electronic Funds Transfer from your bank account**
- **Credit Card (Master Card, American Express, Discover or Visa)**
- **Payment by check**

Withdrawal Policy: Your contract is for the entire school year, from August to May. To withdraw a student from the VCA K-8 Program, a thirty-day (30) written notice is required, and a withdrawal form must be completed by the parent and submitted to the Front Office. You are responsible for tuition payments for the thirty (30) days following notification of withdrawal, even if your student does not attend school. **The August 1st payment is due unless notice is received before June 1st.**

Extended Care Fees

Monthly Installments	3:10pm – 5:30pm	Emergency Drop In
Five Days a Week	\$405	\$50 (per day)
Three Days a Week	\$365	

Late pick-up fees will be applied after 5:30 p.m. at a rate of \$15 per each 15-minute increment or portion thereof, per occurrence, per student. After two (2) occurrences, the late pickup charge of \$15 per 15-minute increment will double to \$30 per increment, per occurrence, per student.

Discounts & Financial Aid

Current Active Military Families Discount

\$175 Military Hold Fee due at registration or re-registration. Applied to 1st month's tuition.

Two or More Students Discounts

5% on the second student's tuition only.
 10% on the third student's (and above) tuition only.
(discounts do not apply if financial aid is received)

Financial Aid: After completing and submitting the enrollment packet and registration fees, your family can apply for financial aid through our FACTS Tuition Management portal.
